

EVENT RULES & TERMS AND CONDITIONS

Health and Safety

The event sessions may take place over irregular and soft ground, as well as debris, wet and loose areas. We cannot be held liable for any injuries sustained due to the environment, as these areas are open to the public. Any debris, which is unknowingly hidden, which may cause harm, In these circumstances Mud-Fit/Evolution Fitness Professionals Ltd and its coaches/trainers cannot be held liable for any injuries incurred as we do not have control of safety on property that has full public access. We urge you while training to be vigilant on hand, feet and body placement. Light conditions may or may not hinder training but can cause an added health and safety risk. Every effort has been taken to risk assess the problems ahead of the session, but we would like you to take the proper action and vigilance and listen to the Coaches/Trainers instructions and advice throughout the event. We ask that each environment you train in you take care of yourself and the others around you and utilize any PPE or safety equipment the coaches/trainers urge you to use.

Variable Weather Conditions

Events will run rain or shine. We will assess as many problems in advance with regards to high velocity wind, fog, lightening, storms and other unforeseen circumstances that will endanger participants and trainers during the session. We reserve the right to cancel any sessions during these circumstances. We urge all participants to bring a change of clothing including waterproofs incase the weather does change.

Car Park Liabilities

Mud-Fit/Evolution Fitness Professionals Ltd or their trainers cannot accept any liability for the loss of or damage to any vehicle or its contents parked on private or public property. You park your vehicle at your own risk.

Change of contact details

We need to keep in touch with you, so if there are any changes with your personal contact information e.g. name, address, email address and telephone numbers, the trainer needs to be notified to up date records, prior to or at the next session.

Data Protection

Your data is securely handled by Mud-Fit/Evolution Fitness Professionals Ltd, This information be used by Mud-Fit/Evolution Fitness Professionals Ltd and its partners to deliver the best possible service. Third parties such as gyms and health clubs require us to submit your details. Any obligations to this, needs to be made to the trainer prior to any session.

Change in Health

If there is any change to your health or you suffer injury, the session trainer must be informed as soon as possible. This also includes the instance of pregnancy or in the case of couples trying to conceive, and those who are on any medication or have recently had changes to medication. Certain diets and clinical trials may have a negative effect on client's sessions; the trainer needs to know if anything is wrong so they can adjust the client's session properly. If you are currently undergoing a medically assisted diet the trainer must be informed.

Drugs and Alcohol

Mud-Fit/Evolution Fitness Professionals Ltd Trainers have a responsibility and duty of care the use of drugs or consumption of alcohol is unacceptable. Anyone found under the influence will not be allowed to take part in the session and will forfeit their fee.

Time Keeping

Sessions start at the agreed time; we offer a 15-minute window from the start time, for any unforeseen circumstance resulting in the late start of the session. The coach/trainer may lengthen the session past the pre-agreed finish time, this would only occur under the coach/trainer's discretion. After the 15-minute window, the coaches/trainer can terminate the session, resulting in the collection of all owed payment up to and including that session from the client, or forfeiting that prepaid session. Any error made by the trainer with regards to time keeping, would have to be taken up with that trainer individually, in that event Mud-Fit/Evolution Fitness Professionals Ltd would maintain a correspondence with all parties until resolution.

Payment and Prices

Method of payment and pricing is agreed prior to commencement of any session(s). Mud-Fit/Evolution Fitness Professionals Ltd maintains a competitive rate on session prices and reserve the right to change its price structure without prior notice having being given. This is to maintain within competition within the fitness industry. We endeavor to provide a high service, which we are constantly trying to improve. Any pricing may not include venue or equipment rental, which may be charged by a third party at extra cost.

24 hour notice period

If the event is not going to run on a particular day, Mud-Fit/Evolution Fitness Professionals Ltd and the coaches/trainers may (but do not have to) give notice within 24 hours of the event time. Any Prepaid dates will be re-reimbursed or carried over. Communication is paramount so please check emails and social media for updates prior to session commencement.

Personal Hygiene and Attire

We may require you to bring along alternative clothing and footwear for training, we also ask you wear appropriate clothing and footwear for the arranged session. Failure to do this may result the client being asked to leave the event without reimbursement.

Liability

Each Coach/Personal Trainer is in ownership of their individual Legal Liability Cover, you would need to speak to your Coach/Trainer if this information is required for any reason.

Venue Rules and Regulations

I understand and acknowledge that these risks include, but are not limited to: falls; illness; infection; contact or collision with spectators, personnel, and other pedestrians; contact or collision with motor vehicles; contact or collision with other participants of varying skill levels; contact and the effects of contact with natural and man-made fixed objects; natural and manmade water, road and surface hazards; close proximity and/or contact with thick smoke; dangers arising from weather conditions, including but not limited to extreme heat, cold, humidity, ice, rain, or fog; imperfect course conditions. The Venue is part of the challenge and the MF & EFP Training Course/Event will usually be held in hostile environments that might include extreme heat or cold, snow, fire, mud, extreme changes in elevation and water. In summary, the MF & EFP Training Course/Event is a hazardous activity that presents the ultimate physical and mental challenge to participants.

I understand and acknowledge that these risks may cause harms including, but not limited to: bodily injury, ranging from minor to severe; illness or infection, ranging from minor to severe; physical and/or mental effects of exposure to extreme conditions and circumstances, ranging from minor to severe; temporary or permanent disability; paralysis; death; and property damage or loss. I understand that the risks of participating in **MF & EFP** Training Courses/Events may be caused in whole or in part by: my own actions or inactions; the actions or inactions of other participants; the actions or inactions of spectators or other pedestrians; and/or the acts, inactions, or negligence of the Released Parties (as defined below).

I also agree to exhibit appropriate behaviour at all times; demonstrate respect for all people, equipment and facilities; and participate with a cooperative and positive attitude. I understand that **MF & EFP** may immediately dismiss anyone who disobeys any rules, directions, instructions, decisions, or laws, or whose behaviour endangers safety or negatively affects a person, facility, or property of any type or kind.

5. I consent to receive medical care and treatment as determined by appropriate **MF & EFP** personnel. In the event of my injury, accident, or illness, I consent to receive medical care and treatment as deemed advisable in the best judgment of appropriate **MF & EFP** and/or appropriate medical professionals. If necessary, I authorise appropriate **MF & EFP** personnel to consent to such medical care and treatment on my behalf.

I agree to assume liability for any and all medical costs incurred as a result of my participation in **EFP** Training Courses/Events but not limited to costs of: medical care and treatment, ambulance services, hospital stays, and physician and pharmaceutical goods and services. I understand and acknowledge that by signing below, I agree that the statutes and laws of the United Kingdom will apply to all matters relating to this Agreement, including participation in **MF & EFP** Training Courses/Events, regardless of the actual location of **MF & EFP** Training Courses/Events or the principles of conflict of laws.
